Indicative Retail Fuel Price Notice - 8th August 2024

The following prices are the maximum indicative retail prices for Petrol, Diesel and Kerosene to apply at service stations at the centres identified. These prices will take effect from 12:01am on Thursday, 8th August 2024, and reflect the Import Parity Prices (IPP) that will apply for the month until the next price change.
